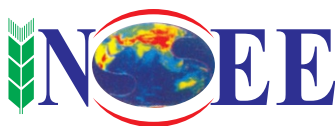
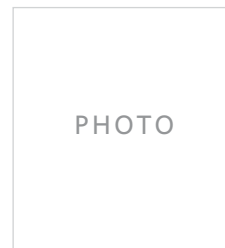

GUIDELINES TO AUTHORS

The International Journal of Extension Education (IJEE), is a yearly journal, published by the International Society of Extension Education (INSEE) in the month of December.

Author should go through the following guidelines before submission of the manuscript

- Type in word document only (.doc) with font size 14 for title with bold, font size 12 for body and subtitles, subtitles should be in bold. Use 1.5 line spacing.
- Manuscript should include Title, Authors name with designation & institute, Abstract, Key words, Introduction, Methodology, Results and Discussion, Conclusions and References.
- First or second author must be the life member of INSEE. Others may have to take annual subscription of Rs. 500/-for the calendar year.
- Only original research papers will be accepted for publication. Same paper should not be published elsewhere (attach declaration).
- Mention the year of research conducted.
- Research based studies conducted with appropriate empirical tests will only be considered.
- Manuscript should be within 5000 words excluding tables, charts, figures, photographs and references.
- Tables, charts, figures and photographs should have proper title or caption.
- If manuscript is accepted no future publication without the consent of the editorial board is allowed

Manuscript guidelines

Title : The title should be unique and concise. It should not exceed 10 to 12 words. The authors names should be centred below the title with designation and institutional affiliation. Abbreviations, acronyms or name of places should not be given in title.

Abstract : The abstract is placed on the next line after institution's name on page1. It should be a concise summary of objectives, methods, results and conclusions not exceeding 250 words.

Key words : 4 to 6 key words should be included in the manuscript. The abstract should be followed by key words.

Methodology : It should include relevant details about the nature of study, research design, techniques employed, locale of the study, sampling and the statistical methods with citations if any. Specify the period during which the study was conducted. Any new technique developed and followed should be described in detail. Do not explain standard methods, only explain new methods developed and used.

Results and Discussion : It should important results of the study with critical interpretation of results. This should not be mere descriptive recital of the data presented in the tables. Unnecessary details must be avoided, but at the same time significant findings and special features should be highlighted. Interpretation and discussion be supported with relevant review. Explain the principles, relationships and generalization that can be supported by the result. Point out any exceptions. The discussion should be based on the results obtained. When results differ from received results, possible explanation should be given.

Conclusion : Appropriate conclusions based on results of the study and implications thereof be given in this section.

Acknowledgments : If unavoidable the author(s) may place on record in brief the help, cooperation, and assistance received during the study.

References : List references cited in text only be given at the end of manuscript. Bibliographical details should be in the order of names of the Authors, Year, Title, Name of the publication, Volume and Issue, Number and Page Numbers. In case of books, name of the publisher and place of publication should be included. All references listed at the end of the manuscript should be cited in the text at appropriate places by surname and year. Cite updated references.

Copyright: The author owns the copyright of the article until the article is accepted for publication. After the communication of acceptance, the copyright of the article is owned by International Society of Extension Education (INSEE).

Submission of Manuscript : After going through all the aforesaid guidelines author shall submit the manuscript along with covering letter and duly signed prescribed [declaration](#) to the "Chief Editor / Editor, International Journal of Extension Education, Division of Extension Education, College of Agriculture, Nagpur-440001, Maharashtra, India".
